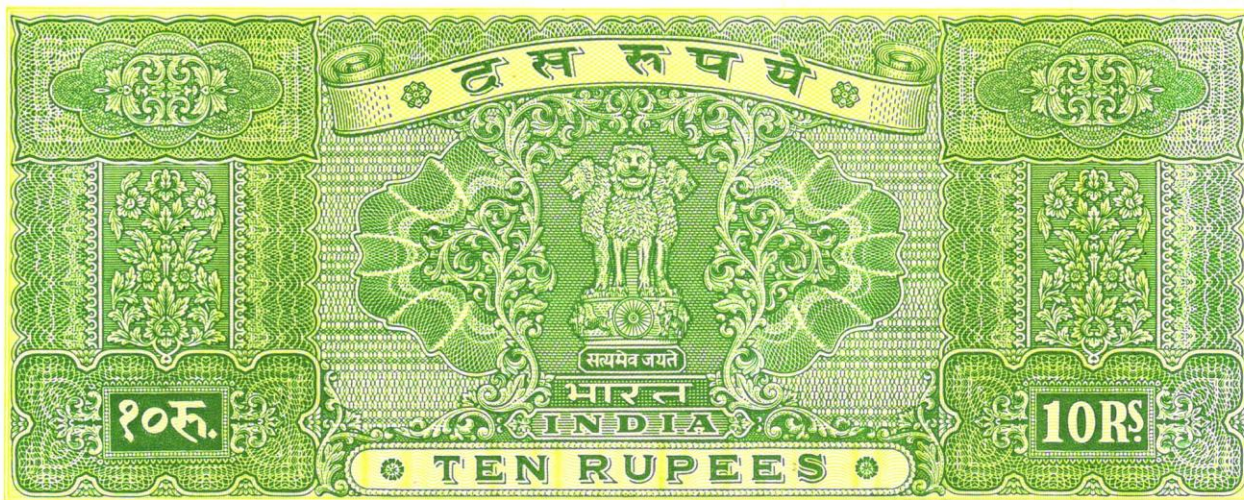

## THIS DECLARATION OF PUBLIC CHARITABLE TRUST

Executed on this Tuesday the 2nd April, 2002 by **Thangjam Kiranjit Meitei** aged about 24 years, son of **Th. Kumar Meitei**, by profession a **Computer Technician** residing at **Kyamgei Mayai Leikai, B.P.O. Kyamgei, P.O. Canchipur - 795003, P.S. Singjamei, Manipur, India**, hereinafter referred as **"The Founder"**

WHEREAS the Founder is desirous of creating a Trust for carrying out public charitable objects and purposes wide enough for the extension of the benefit thereof to all, irrespective of caste, creed, community & religion and relief of poor, education, relief, Self-Help Group Programmes, Eterpreneurship and Micro Enterprises, Art and Culture, Promotion of Youth Activities and Training, Promotion of Adventure, Women and Children Programme, Health, Sanitation and Family Welfare Programme, Library & Book Promotion Programme, Publishing Programmes, Symposium, Seminars, Research Work, Documentation, Natural Resource Development and Management, Science and Technology, Small Scale Industries, K.V.I.C, Rural Infrastructure Development Programme, Income Generation and Market Access, Empowerment of Rural Women, SC, ST and Disadvantage groups and for persons with Disabilities in rural areas, Human Resource Development Programme, Technology for Rural Development and Promotion of Information Technology and Advancement of any object of general and/or public utility and so that such benefit may be given directly by the said Trust.

AND WHEREAS the Founder is possessed of a sum of Rs. 2,000/- (Rupees two thousand) only and the same shall be held by the Trustees, named below, for the object and purpose of the Trust, on the terms and conditions hereafter appearing :

6. The objectives and purposes of the Trust shall be :

- i) To create awareness among the people residing both in rural and urban areas including SC/ST and backward classes for their development programmes, rural development, welfares of children.
- ii) To work with Government, NGOs and other agencies working for health programmes to make community health a reality through peoples participation and involvement.
- iii) To impart training programmes to individuals and groups in Handloom and Handicrafts. Bamboo products, Rural Industries Programme (RIP), Khadi & Village Industries Commission (KVIC), , Crafts Training Centres, wood Carving, Stone Carving etc.
- iv) To organise the programmes for agro-based projects and agricultural allied activities, wasteland development projects, wasteland management, post-harvest programmes, land development, dryland development programmes, desert and prone areas programmes, poultry, piggery, goatry, dairy, pisciculture, floriculture, fishery, duckery, apiculture and other income generating programmes.
- v) To promote cultural programmes, construction of cultural hall & training centres, production of plays, tradition folklore, art and culture, preservation of ancient Tribal Art Forms etc.
- vi) To establish the institutions, disabled schools, ashram schools, boarding schools, street boys and orphanage home, destitute home, old aged homes, day-care centres, short-stay homes, counselling centres, yoga schools, research centres, welfare of widows etc.
- vii) To create and awareness among people in public health and sanitation, environment and ecology for maintaining a hygienic surrounding and to take programmes for prevention of epidemic and disease/pollution, relief/rehabilitation of victims of natural categories, help to victims of riots/other disturbances.
- viii) To act as channel of exchange of experiences, ideas through seminar, workshops, conference, group meetings, demonstrations, talk & discussions, exhibitions, fairs and festivals, road safety programmes, consumer Awareness programmes, Consumer Information Centre, Legal awareness programmes, field visit, research works for the development of SC/ST/OBC people, development programmes, lending policies guidelines of NSK & FDC, NHDFC, NMFDC etc.
- ix) To inculcate a sense of natural unity by involving people from various walks of life in the programmes of social development and other character building activities, development and co-operation in national, regional and international levels, providing free legal aid/running legal aid centre.
- x) To set up rehabilitation centres for chemically dependents and mentally retarded persons, handicapped persons, construction of running hostels for poor students, purchase and supply of educational material-books, note books etc.

- xi) To take up schemes and projects for construction of low cost houses, sanitary latrines, chulah, bio-gas plants, non-conventional energy resources, innovative stream, IVR, rural water supply programmes, agricultural lift irrigation in rural, SC, ST, OBC and remote areas, digging bore wells/hand pumps, sanitation including community toilets, environmental programmes, social forestry projects etc.
- xii) To organise programmes for prevention of anti-social activities such as AIDS/HIV, drug users, immorality, prostitution, child labour policies, holding of free medical/health/family welfare/immunisation camps etc.
- xiii) To conduct and establish vocational trainings in Wool Knitting, Embroidery, Tailoring, Weaving & Spinning, Shorthand & Typing, Computer, Mat-making, Carpentry, Gem Cutting, Offset Printing, Cooking, Bakery & Food processing, Photography, Photo Farming & Lamination, Printing, Composing & Book Binding, Screen Printing, Tie & Die, Spray Painting & Denting, Welding & Fitter, Jewellery, Black smith, Iron & Steel fabrication with a view to upgrade skill to enable them to start income generating activities on their own or get gainfully regarding generating their own or get gainfully regarding generating their own self employment & Enterprises i.e. eradication of unemployment.
- xiv) To take up projects and schemes for plantation and products of aromatic plants, medical and non-medicinal plants by forming SHGs.
- xv) To organise adventure programmes like trekking, hiking, mountaineering, rafting, Canoeing and Kayaking and other dare-devil activities which would aim at development of leadership qualities, endurance and courage etc.
- xvi) To help farmers, artisans, war widow, women headed persons, educated unemployed youths, women and children entrepreneurs, SHGs, small saving groups, poor and needy persons in obtaining all such supplied, loan, grants, income generating programmes and facilities as are required by them including credit and other inputs, implements, infrastructure, tools customs and managerial services, whatever necessary and possible, micro finance project including setting up banking co-operatives and self-help-groups (SHGs).
- xvii) To invest and utilize the income and property of the trust in establishing hospitals, health related institutions, educational institutions, sports hostel and organising different programmes for the fulfillment of aims and objectives of the trust from time to time.
- xviii) To do all such other lawful acts, deeds or things either by Trust alone or in conjunction with other organisations as are incidental or conducive to the attainment of any of the above objects.
- xix) To set up the training & production centre of Food Processing Units, Cold Storage, Chilling Plants & other required processing units.

- xx) To raise funds by receiving admission fee, sale process, donation, subscriptions, contribution, housie (Tambola), charity show, gifts, grants, securities, properties etc. in cash or kind from members, non-members, staff contribution, individuals, donors, society, trust, NGO, Government Departments from any facility/part within and outside of our country.
- xxi) To organize training relevant to rural development programmes for full/part time workers, farmers, artisans, women, youths etc. and to prepare print and/or publish books, periodicals, pamphlets, IEC, leaflet, literature, papers and other educative or publicity material for dissemination of information, knowledge and create awareness among the masses.
- xxii) To acquire by gift, purchase, exchange, in lease or hire or otherwise any lands, buildings, documents and any other property movable and/or immovable and for any estate or interest or interests for the furtherance of all or any of the object of the Trust.
- xxiii) To approach or seek loans, borrowing, grants and subsidies etc. from banks, funding agencies, Financial Cooperations & Institutions, government and non-government agencies etc. and to pass into the economically backward classes/minority/weaker section/Scheduled Cast/Tribe, member and non-member in the form of loan grant and subsidies etc. in accordance with nature of the schemes and projects.
- xxiv) To arrange promotion of savings, thrifts and lending among the poor and needy women, girls, other backward classes, safai karmachari, ST/ST, Minorities of the organised or unorganised sector of Rural, Urban and Urban slum areas of the communities for their welfares.
- xxv) To organised and implement youth activities with a view to promote National Integration Camp, Empowerment of Adolscents, Cultural Festival of Communal harmony, Youth exchange programme, Youth festival, Cultural exchange programmes, Youth leadership training programme, Youth entrepreneurship training programme, Social service camp, Youth training centre and also for taking up through social development activities for the Nation.
- xxvi) To organise Vocational Training in assemble & repairing of TV, VCP, Radio and Tape, Computer Machine, Xerox Machine, Mobile Phone, Sewing Machine, Diesel Pumps & Engine, Saw Mills, Electric Motor, Refrigerator & Air Condition, Type Machine, Camera, Cycle, Scooter/Motor Cycle/Auto rickshaw/Tractor etc to enable the unemployed Youth to be self employed.
- xxvii) To associate/affiliate with all such trust or agencies having objective similar to the trust and open brances of the trust at village, Block and District level.
- xxviii) To award grant, scholarships, prizes, stipends, research and fellowships to Childrens, Students, Youth, Girls and Women etc.
- xxix) To promote the indigenous system of AYUSH, Nature Cure and Yoga, Naturopathy Health Education etc.

- xxx) To conduct, establish and open essential training and research centre on sports & allied activities such as kits for various sports & adventure, improvement in critical areas of sports infrastructure, training and promotional input for improving performance of players and organisation of village, blocks, district, state, regional & national level tournaments/championship etc.
7. Any of the said Trustees may at any time resign his office of the Trustee. However, the President will have the power to dismiss any trustee (except the Founder Trustee) at any time for proper functioning of the Trust.
  8. The trustees shall have the power to acquired by purchase, lease or otherwise and to dispose off by sale, mortgage, etc. any or all movable or immovable properties of the Trust.
  9. The Trustees shall be entitled to open and maintain in the name of the Trust, Bank Account or Accounts with any bank or banks as they from time to time may decide and all such bank accounts shall be operated jointly by the President and one more Trustee duly authorised in this behalf by the remaining Trustees.
  10. The Trustees shall be paid remuneration for the services renewed by them to the Trust and they are entitled to be reimbursed all expenses incurred for the Trust out of the Trust fund.
  11. The Trustees shall have full power to invest all surplus of the income after meeting the expenses of the Trust in or upon any investments in accordance with the provision applicable of Income Tax Act, 1961.
  12. The Trustees shall keep proper books of accounts of the Trust fund and get the same audited every year by a firm of Chartered Accountants.
  13. The administration of the Trust will be vested on the Trustees and majority rule shall prevail but in the events of tie, the President shall have a second or casting votes.
  14. The Trustees shall have the power to employ, dismiss or terminate the engagement or services of any Solicitors, Counsel, Banker(s), Manger, Secretary, Officer, clerk, Servant. Employees or any other person(s) to transact any business of the Trust, and shall be entitled to pay all charges and expenses incurred thereby out of the Trust fund.
  15. None of the said Trustees shall be liable for loss occurred to Trust in respect of any dealings carried out on behalf of the Trust by the Trustees on good faith and the said Trustees shall be indemnified by and out of the fund of the Trust against any loss or damage which the Trustees might suffer in regard to any act or deed in performance of their duty(ies).

THIS supplementary Trust Deed of Unique Trust, Kyamgei Mayai Leikai, P.O. Canchipur, P.S. Irilbung, Pin – 795003, Imphal East District, Manipur made on 8<sup>th</sup> February, 2016 in continuation of original Trust Deed dated 4<sup>th</sup> April, 2002.

1. **AREA OF OPERATION :**

That all activities of the Trust shall be extended to the territories of India.

2. **IRREVOCABLE :**

That the Trust is irrevocable.

3. **DISSOLUTION OF TRUST :**

In the event of the Trust closing down all its institutions/ centres and other activities carried on under the terms of this deed, the Trustees shall after paying off all the liabilities of trust out of assets in hand give out the balance if any, to any such Trust or Organisation or society having similar objects, as may be decided by the Board of Trustees by a majority of at least three-fourth (3/4<sup>th</sup>) vote. But in no case the balance be handed over to the Settler and/ or trustees or any of their relatives.

4. **UTILISATION :**

To apply the whole or part of the income of the Trust or accumulation thereof or whole part of the corpus of the Trust Fund for one or more of the object of the Trust may determine from time to time.

5. **AMENDMENTS :**

The Board of Trustees may amend or alter any of the clauses except those relating to objects of the Trust. If any alteration or amendment is required, the same shall be effected through supplementary deed/deeds.

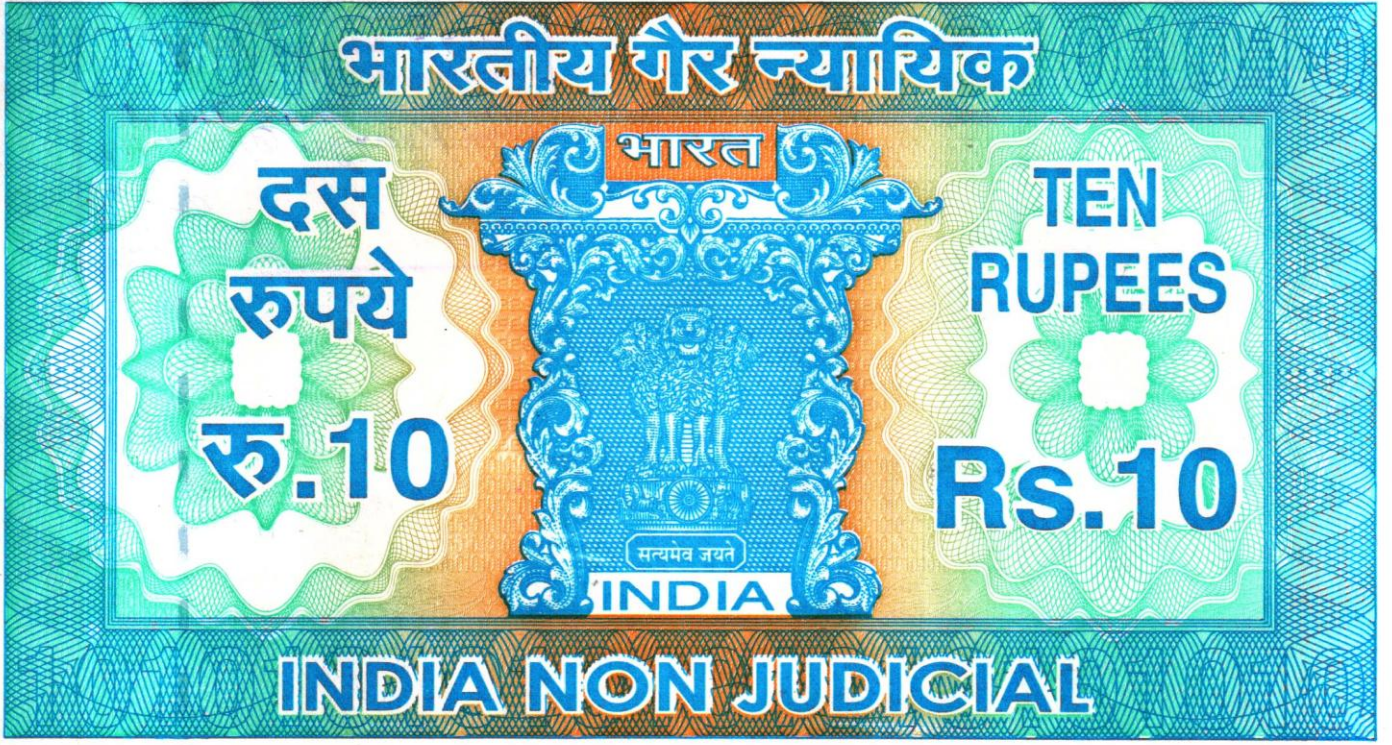
